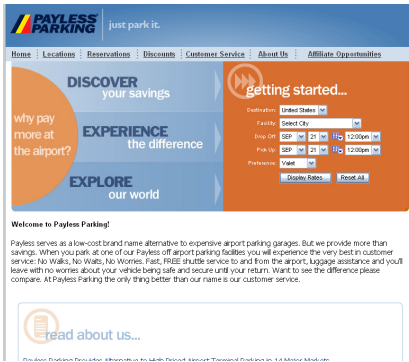

In addition to providing car rental services, both locations provide airport valet parking services using the Payless Parking brand.

In September 2004 the Company purchased the assets of the former Las Vegas franchisee. This acquisition resulted in 2 new corporate store locations servicing the McCarran International Airport and Nellis Air Force Base. Further expansion was achieved with the purchase of the Denver, CO franchise in May of 2005 and that of the Fort Lauderdale, FL location in July of 2005. Expansion continued in 2006, with an acquisition of a corporate store in Sky Harbor International Airport, Phoenix Arizona in 2006.



As a part of its growth strategy, the company is currently evaluating the purchase or additional rental stores in strategic markets.
